Patricia Leary

Patricia is a passionate nonprofit professional with over a decade of experience in public policy, community organizing, youth development, and fundraising. She recently worked as the Manager of Community Engagement and the Women's Initiative at the United Way of Central MA. She was the Community Advocacy Director for the American Heart Association and the Grassroots Manager at the American Cancer Society's Cancer Action Network, where she was awarded the Grassroots Professional of the Year award for her work to engage volunteers.
